# Certificate of Origin

## U.S. / Chile Free Trade Agreement Instructions

---

**1. Enter the name and address and tax ID number of the U.S. exporter of the goods.**

**2. Enter the name and address and tax ID number of the producer of the goods.** The producer is the manufacturer of the finished goods being exported or the processor, mine, farm, etc., if raw materials are being exported. If it is the same as #1, enter "same."

**3. Specify the dates of effectiveness of the blanket certificate of origin** period if applicable (up to one year).

**4. Enter the name and address and tax ID number of the importer** located in the destination country of the shipment.

**5. Describe the goods or commodities being shipped** for which preferential tariff treatment is being claimed under the free trade agreement.

**6. Enter the Harmonized Tariff System classification number** for each commodity being shipped (first six digits only).

**7. Enter the Preference Criteria** code letter (A, B, or C) in accordance with the U.S. / Chile Free Trade Agreement Rules of Origin.

**8. State whether you are or are not the producer of the goods.** If you are the producer of the goods, state "Yes." If you are not, state "No" and refer to your evidence that the goods qualify (such as "CofO from producer").

**9. Regional Value Content Rule statement.** If not subject to Regional Value Content rule, state "No." If subject to RVC, state "Buildup" or "Builddown" depending on which method was used.

**10. Identify country of origin** which will be "US" or "CL."

**11. Sign and complete identifying information.**
